
**Subject: Gross Vehicle Weight Ratings Reclassification for Certain 2005 and 2006 Model Year  
F-350 Super Duty Vehicles**

In 2005 Ford Motor Company (Ford) produced 46 complete F-350 Super Duty pick-up trucks with a Class 3 (10,001 – 14,000 pounds) gross vehicle weight rating (GVWR) for Canadian National Railway Company, headquartered in Edmonton, Alberta. Although the fleet is owned by a Canadian customer, the 46 units are operated in the United States. Ford will be reclassifying the GVWR on these vehicles to Class H (9,001 – 10,000 pounds) to make them equivalent to subsequently produced vehicles with similar content, at the request of the fleet.

As directed in your July 8, 2005 email to a member of my staff concerning a previous similar reclassification of certain other Super Duty pick-up trucks, Ford is providing the agency a list of the vehicle identification numbers for these 46 vehicles in the attached document. Ford is also providing this information via separate letters to the National Insurance Crime Bureau and the American Association of Motor Vehicle Administrators.


