Submission of REVISED Vehicle Identification Number Coding
System for 2006 Suzuki Grand Vitara and Suzuki Grand Vitara XL-7

On behalf of Suzuki Motor Corporation, Hamamatsu, Japan, we hereby submit the above referenced REVISED report in accordance with 49CFR, part 565, 7 (c)&(d). The vehicle model name Suzuki Grand Vitara XV6 has been dropped from Suzuki's marketing plans. The vehicle will be marketed as the Suzuki Grand Vitara without the 'XV6' designation.

We have attached a revised encoding page for the Suzuki Grand Vitara and Grand Vitara XL-7 to reflect this change, as well as a marked up page showing the location of the change from our initial submission. For your convenience we have also attached a copy of the VIN encoding for the Suzuki Aerio passenger car.


